Grant Expenditures

As we approach the middle of the fall semester, please ensure you are on track with your grant expenditures. Following are a few basic tips:

- Every employee whose salary is charged to a grant, in whole or in part, must maintain time and effort sheets that account for all of their compensated time, including time spent on other activities. Ensure that payroll has the correct account number for all of your grant funded employees.
- Only expend funds as laid out in the approved grant budget. Never use funds from a grant for items not included in the grant budget or for purposes other than described in the grant narrative.
- If you need to modify the original budget, the grant funder must be notified. Please contact the GDO or refer to your grant manual for further instructions.

U.S. Department of Education

Rethink Adult Education Challenge Deadline: November 25, 2020 Award: \$100,000 - \$250,000

The U.S. Department of Education's Office of Career, Technical, and Adult Education invites adult education providers to submit designs for pre-apprenticeship programs that better prepare learners for apprenticeships and beyond. Pre-apprenticeship programs should include academic instruction, such as math and literacy, and workplace skills training (e.g., time management and conflict resolution). Programs should also teach participants about specific industries, including workplace norms and expectations or the tools and machinery they might use on the job. In phase 1 of the competition, applicants submit preliminary pre-apprenticeship designs. In phase 2, selected applicants will have access to a range of digital resources (e.g., case studies, activities, and webinars with subject matter experts) to develop and submit more detailed program designs. The grand-prize winner will receive \$250,000, and five runners-up will each receive \$100,000.

American Association of University Women (AAUW)

Community Action Grant Deadline: December 1, 2020 Award: \$3,000 - \$10,000

Founded in 1881, the AAUW is the oldest women's organization in the U.S. and advances equity for women and girls through advocacy, education, and research. Community Action Grants fund individuals, AAUW branches, AAUW state organizations, and community-based nonprofits that promote education and equity through projects focused on encouraging girls to select, before entering college, the physical sciences or engineering as a career.

Disabled American Veterans (DAV) Charitable Service Trust

Community Action Grant Deadline: October 30, 2020 Award: Unspecified

Established in 1986, the DAV Charitable Service Trust advances programs and services that cater to U.S. veterans as well as their caregivers and families. The Trust's mission is to empower veterans to lead highquality lives with respect and dignity. To fulfill this mission, the Trust awards grants to promote food, shelter, and other necessary items to homeless or at-risk veterans; mobility items for veterans that have experienced vision loss, hearing loss, or amputations; therapeutic or recreational activities for those with physical and/or psychological limitations; and *education or training for veterans seeking career-readiness* and skill development.

Deadline: November 1, 2020 Award: \$5,000 - \$20,000

The Kinder Morgan Foundation supports programs that benefit traditionally underserved K-12 youth, including minorities and girls. The Foundation supports academic programs (including tutoring) and arts education programs, although they direct a majority of their contributions to STEM programs. Fundable projects have clearly defined objectives and benefit the community in which the applicant organization resides.
